Guidelines for Honor Spirit Selection:

- 1) Each nominee must have a current registration in Suffolk County Council BSA
Have demonstrated outstanding service to Scouting, community, Religious Institution, and family. (That one youth that stands out, who is consistently willing to lend a hand in their unit, community and/or religious activities)
- 2) Only ONE Scout per District and one Council Scout will be selected. Nominations can be made by all registered Scouters, COR's, Religious leaders, Teachers, etc.
- 3) District nominees will be selected from Cub Scouting or Scouts, BSA. Council nominees will be selected from Venturing, Explorer and Sea Scouting.
- 4) Those individuals making nominations are expected to make selections based on their familiarity with the Scout and his / her achievements.
- 5) Nominee forms will be distributed beginning in September 2021 at RTs and expected back to each District Executive no later than **January 3, 2022**, so they may make selection.
Again, it is recommended that each District have their District Executive receive the nominations.
- 6) Final Selection will be made by the District Committee.
- 7) Council nominees should go to Lauren Vlachos.
- 8) Upon being selected, the Scout will be honored at the 2022 Fellowship Dinner. The Scout and one parent/ guardian are invited as our guests. Others are asked to attend to celebrate and honor the Scout, at their cost.
